



Facts:

1. The appellant filed an RTI application on 23-11-2012 seeking information about the casualties during the 1947 Partition.

2. The CPIO responded on 18-1-2013. Some information was provided while other information was denied on the ground that it was not maintained by the respondent organization. The appellant filed an appeal with the first appellate authority (FAA) on 29-1-2013. The FAA responded on 6-3-2013 and upheld the decision of the CPIO. The appellant approached the Commission on 10-4-2013 in a second appeal.

Hearing:

- I heard the appellant through video-conferencing.
- He referred to his RTI application of 23-11-2012 and stated that he wants the following:
 - (a) the number of casualties resulting from the partition of 194 including the community-wise break-up;
