Subject: First Appeal filed by Shri Samir Chakma under the RTI Act, 2005- regarding Shri Samir Chakma in his Appeal dt 29.4.2013, inter-alia, stated that he sent on 28.2.2013, an RTI petition addressed to Dr.M.C. Mehanathan, CPIO of this office, who, according to the appellatant, did not supply any information so far.

2. I have carefully perused the appeal and also the relevant file on the subject. Dr.M.C. Mehanathan, the CPIO of this office on receipt of the RTI petition dt. 28.2.2013 from Shri Samir Chakma has duly sent a reply dt. 18.3.2013, a copy of which is enclosed for ready reference.

3. Whatever information available with this Division has already been provided to the applicant vide this Divisions communications, including my earlier order dt. 18.3.2013. The information sought by para 1 of the application dt. 28.2.2013 so far as the NE Division is concerned is nil. Photocopies of the communications sought vide the remaining paras of the application dt. 28.2.2013 are not available with this Division as they pertain to the respective State Governments. The Appellant is free to approach the PIOs concerned of the State Govts.

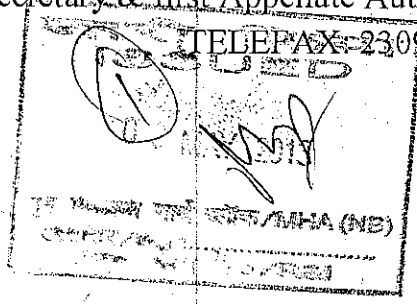
