



2. Copies of all recommendations made for Presidential award for Addl. CP, Sh. Anil Kumar Ojha.
3. Please clarify as to whether the following complaints mentioned below were taken into consideration or not? Kindly intimate the details of action taken, if any, and the status, as on date, of the following complaints:-
 - a) Receiving No. 78162 dated 18.3.2013 forwarded to Home Minister by Dr.G.Sanjeeva Reddy.
 - b) Receiving No. 80613 dated 22.3.2013 to Home Secretary
 - c) Receiving No. 91715 dated 17.4.2013 to Joint Secretary Union Territory
 - d) Receiving No. 106310 dated 17.5.2013 to Joint Secretary Union Territory
 - e) Receiving No. 106308 dated 17.5.2013 to Home Secretary
4. Did any senior officer of Police Force got demoted by Ministry of Home affairs due to his/her high handedness and misuse of power and position held by virtue of occupation of the public office?
