

- 1) Kindly give me the exact definition of CILEQ i.e. Compensation in lieu of quarter available with Government of India, copy of the G.O.? is CILEQ different from H.R.A (House rent allowance) or is an additional allowance to it, give information in written, copy of G.O. i.e. an employee getting HRA will get CILEQ in addition to it, if she/he is/has not been provided rent free accommodation at her/his place of posting?
- 2) What was the rates of CILEQ in the 5<sup>th</sup> Central Pay Commission and the 6<sup>TH</sup> Central Pay Commission pay scale wise or entitlement wise?
- 3) Is CILEQ admissible to Gazetted Officers or not or is it only applicable to non Gazetted Central Government Employees ? is it only applicable of Direct Group A or direct Group B or both, please provide specific reply and provide G.O. ?
- 4) Is CILEQ admissible to civilian employees or not or it is admissible only to uniformed employees of Army, Paramilitary i.e. CPMF & CAPFs & other non-uniformed central Government Officers and Officials or both are entitled to avail it if they are not provided rent free accommodation at their respective place of posting?
- 5) Is in Assam Rifle CILEQ is authorized for Gazetted Officers too, please provide the copy of the order ?
- 6) What if F.A.A or Family Accommodation Allowance is it applicable for combatised personnel or its is applicable for civilians .i.e. non uniformed is it different from CILEQ or is in addition to it? Is paramedic non Gazetted and non-uniformed officials of the Area wing of SSB authorized to draw CILEQ or FAA or both ? 7) Provide the copy of the order issued by Under Secretary to the Government of India Sh. H Kam Suanthang M.H.A vide O.M. No. 2713/32/200-PF-IV in 2007 to S.S.B, which says that CILEQ is authorized only to the authorized strength of S.S.B and only to combatised personnel's .i.e. uniformed of S.S.B, is it applicable on the Area Wing Officers, do the Area side civilian Executive cadre officers eligible for CILEQ, FAA or both, Do they come under authorised strength of S.S.B as CAPF under M.H.A is post of Area Organizer in S.S.B is a combatized post ,as it is mentioned in the Recruitment rules of Deputy Inspector General of Sashastra Seema Bal and is this post equal or is senior to the post of Commandant of the uniform wing of S.S.B ? Kindly provide equivalency table of both the wings of Sashastra Seema Bal .
