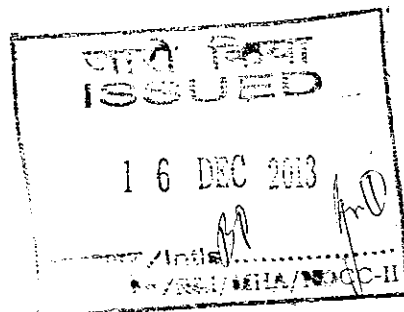

Sub: - Hon'ble Governor of Andhra Pradesh – functioning under the State laws- Regarding

I request the Public information officer to provide the following documents / information

1. Copy of the provisions of the Constitution/rules made by the President of India authorising the Secretary to the President of India to fix the terms of appointment of the Governor of Andhra Pradesh superseding the Article 156 of the constitution vide letter No. F.11-CA(I)/2010 dated 17th January 2010 and No. F.11-CA(I)/2012 dated 28th April 2012.
2. Copy of the provisions of the Constitution/rules made by the President of India for the state of Andhra Pradesh to function without a Governor (during 5 to 18 November 2008 when ND Tiwari is out of the Country).
3. Copy of the provisions of the Constitution/rules made by the President of India for the Governor when acting as Chancellor (an officer of the University under a State Law) to use the officers of the Raj Bhavan and Government machinery for performing the functions under the University Acts.

4. Can a person with infirmity of mind be appointed as Governor of a State as the qualification for the appointment of Governor under article 157, if he is a citizen of India and has completed the age of thirty-five years
5. Copy of the evidence/ proof regarding functioning as Chancellor of the Universities by Mr. E.S.L. Narasimhan, who by virtue of his office as governor is the head of the University and the Chancellor of Universities in the State of Andhra Pradesh.
6. Can a person who cannot read and understand the constitution and the law establishing a university is by virtue of his office as governor, be the head of the University.
7. Can a person who is the governor sign a government department note-file as governor and chancellor of a university and can the decision of the predecessor be ignored by the incumbent governor in the appointment of the vice-chancellor of a university(copy enclosed).
8. What is the remedy when a person by virtue of his office as governor is the head of the University and chancellor does not uphold the law and does not function as prescribed and violates the law governing the Universities?

I request you to kindly acknowledge the receipt of the application. I am enclosing an IPO for Rs. 10/- (No. 14F 602829) in favour of Pay and Accounts Officer, Rashtrapati Bhavan payable at New Delhi as application fee.
