Please refer to your RTI application dated 08.03.2014 received on 27.03.2014 seeking information under RTI Act 2005. In so far as NE Division, MHA is concerned, the information available is as under:

- 1) Tripartite talks with ULFA (Arvinda Rajkhowa) group, NDFB (Gobinda Basumatary) now renamed as NDFB -Progressive group and NDFB (Ranjan Daimary group are continuing. SoO Agreement with NDFB and NDFB (Ranjan Daimary) groups were signed and is being implemented w.e.f. 01.6.2005 and 29.11.2013 respectively, while SoO Agreement with ULFA was signed on 3.9.2011.
- 2) Tripartite talks with NDFB have been continuing since the signing of SoO Agreement on 01.6.2005. However, they had submitted their charter of demands in August, 2009. NDFB (Ranjan Daimary) group is yet to submit its charter of demands. ULFA had submitted charter of demands in the year 2011.
- 3) & 4) Details of charter of demands submitted by ULFA and NDFB (P) cannot be disclosed in Public Interest. Their demands are being examined in consultation with the Government of Assam.

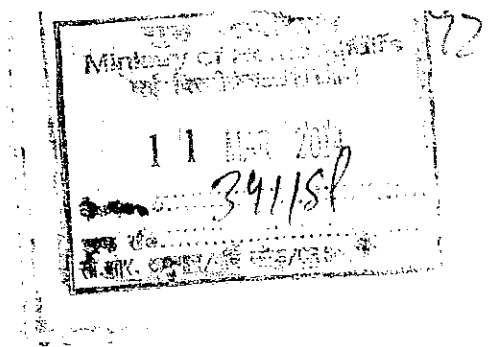
