Whereas Shri Rishabh Agarwal (hereinafter referred to as the **Appellant**) vide Registration No. MHOME/A/2013/60068 has preferred an appeal under RTI Act, 2005 in connection with his RTI application dated 19.7.2013 (Reg. No. MHOME/R/2013/60401).


2. Whereas the appellant had sought information relating to residence allotted to former Presidents and their spouses. It has been stated by the appellant that he has not received the response within the time limit.

3. Whereas from the records available with the CPIO, it appears that the above referred RTI application had not been received by the CPIO. However, a copy of the RTI application has been received along with the appeal.

4. Whereas the Ministry of Home Affairs is only administratively concerned with the President's Emoluments and Pension Act, 1951 and the rules framed thereunder, which deals with Salary of the President and post retirement benefits for the former Presidents and as per the aforesaid act and rules the Directorate of Estates, Ministry of Urban Development shall be responsible for arranging accommodation for the former President and the surviving spouse.

5. It is, therefore, ordered that the CPIO may transfer the RTI application to the Directorate of Estate, Ministry of Urban Development under Section 6(3) of the RTI Act for providing the requisite information to the appellant.

6. The appeal stands disposed accordingly.

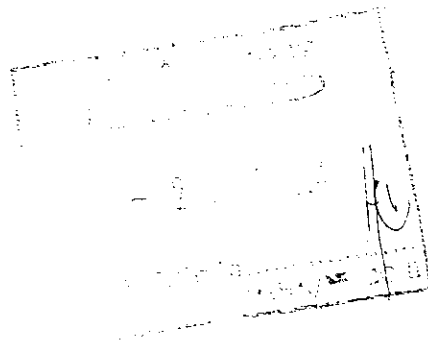
