

¹S.R.O. 460, dated the 24th August, 1950.—In pursuance of clause (1) of article 239 of the Constitution and in supersession of all previous notifications on the subject, the President is pleased to direct that the Chief Commissioners of Himachal Pradesh, Bilaspur, Kutch, Bhopal, Tripura, Vindhya Pradesh and Manipur shall, subject to the control of the President, and until further orders, exercise the powers and discharge the functions of—

- (1) a State Government under the provisions of laws as for the time being in force in their respective States specified in Schedule I hereto annexed ;
- (2) The Central Government under the provisions of laws as for the time being in force in their respective States specified in Schedule II hereto annexed.
