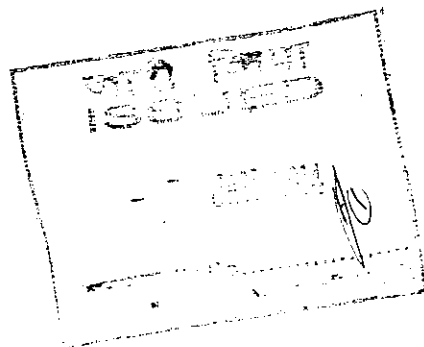

Sir,

With reference to point number five of your RTI applications dated 29.11.2013 & 05.12.2013 and MHA OM No. A-43020/01/2013-RTI dated 09.12.2013 & 19.12.2013 on the subject mentioned above, it is stated that the President of India is entitled for an emolument of Rs. 1,50,000/- per mensem. The Prime Minister is entitled to receive a salary at the rate of Rs. 50,000/- per mensem. Besides this, Daily Allowance at the rate of Rs. 2000/- for each day during the whole of his term, Constituency Allowance at the rate of Rs. 45,000/- per mensem and Sumptuary Allowance at the rate of Rs. 3000/- per mensem.

2. As regards the salary of the Vice-President of India, your application is being transferred, under Section 6(3) of the RTI Act 2005, to the Ministry of Parliamentary Affairs for providing the requisite information.
