
Sir,

Please refer to your online RTI application No.MHOME/R/201361862 dated 28.11.2013 seeking information under RTI Act, 2005. In so far as NE Section is concerned, the information is as under:-

2. As per report, in Assam incidents of violence took place between the two communities on socio-economic issue in some districts of Assam during the year 2012 which claimed 109 lives of the civilians and injuries to 140 persons. 5,776 Police cases were registered against the miscreants found involved in the violence. Out of this eight cases are handed over to the Central Bureau of Investigation (CBI) for investigations.
3. As regard, complete list of persons killed in ethnic violence in Kokrajhar, Chirang and Dhubri District in Assam between July and November, 2012 alongwith details of the case registered in the respective Police Stations are maintained at the State level. You are requested to kindly approach to the State Government authorities to obtain the desired information.
4. As per record available, Joint Secretary (North East), MHA had not written any letter to Government of Assam between 23rd - 30th November, 2013.
5. An appeal, if any, in the matter lies within a month to Sh. Shambhu Singh, Joint Secretary (NE), Room No. 109/C, North Block New Delhi-110001.
