2. In this regard, it is stated that security to an individual (including private citizens) is provided at government cost on the basis of threat assessment carried out by the Central Security Agencies. On the basis of gravity of threat, categorized security cover to an individual is provided. Further details in this regard including nature and details of security provided to an individual, are exempted under Sections 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005 and cannot be disclosed.

3. Regarding expenditure incurred on security, it may be stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to estimate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
