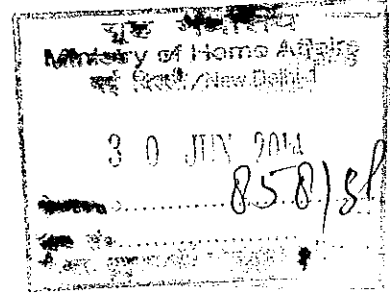

Subject -! In continuation of my letter dated 7.6.2014 under Whistle Blowers Protection Act 2014 against D.I.G., C.R.P.F., New Delhi Mr. Sandeep Yadav.

Sir

In my aforesaid letter I had made 'disclosure' within the meaning of Whistle Blowers Protection Act 2014 regarding offence under section 497/511/292 of Indian Penal Code committed by Mr. Sandeep Yadav. I had so many telephonic conversations with Mr. Sandeep Yadav after 1.6.2014, when I caught the entire evidence and preserved in my possession. On 14.6.2014 I had telephonic talks with Mr. Yadav.

on the number used by Mr. Yadav
in this entire episode i.e. 8826639887
by mobile number number 09997240909
at about 8 P.M on 14.6.2014.

Mr. Yadav tried to
counter charge me and then I kept
on abusing him. Mr. Yadav kept
mum ^{and said yes} to my charge that he has
two immovable properties at
Chhaziyabad and New Delhi in his
own name and in the name of
his wife Chitra Yadav. Mr. Yadav had disclosed
this fact to my wife. Mr. Yadav then rang me
at about 8.25 P.M on 14.6.2014 and
admitted that he had sent the chat
to my wife

1. "Teri chut se pyari koi chiz
nahi hai"

2. "Aur andar te"

3. "My sexy bitch"

4. "tere piche karunga piche se
kyo gabrati hai maini ek bar
chitra ke lene kiya tha"

5. The clippings of lene film sent
by Mr. Yadav to my wife.

Mr. Yadav time and again after
Yes I have abused

The incident because after all ⁽³⁾
I am a human being.

But from the conversations dated 14.6.2014 it is clear that adultery was u/s 497 & offence u/s 292 I.P.C. is proved against Mr. Yadav. I am enclosing the audio C.D. of both the conversations with this letter.

I do hereby pray

- (i) I must be protected from victimization and my identity should not be disclosed under section 11(1) of Whistle Blowers Protection Act 2014
- (ii) An action not less than dismissal from service must be taken against Mr. Yadav.
- (iii) Mr. Yadav must be charged with offence of Corruption for non disclosing his immovable properties of New Delhi and Chaziasad, under Prevention of Corruption Act because Mr. Yadav did not inform the department about his funds and properties

Subject :- In continuation of my letters dated 7.6.2014 and 17.6.2014 under whistle Blowers Protection Act 2011 against D.I.G. C.R.P.F., New Delhi Mr. Sandeep Yadav

Sir

In my two letters dated 7.6.2014 and 17.6.2014 I had sent audio c.d. & nine photographs and made 'disclosure' within the meaning of whistle Blowers protection Act 2011 regarding the offences under section 497 & 292 of Indian Penal Code and offence under Prevention of Corruption Act committed by Mr. Sandeep Yadav, D.I.G., C.R.P.F. - N.D.

I had further telephonic conversations with Mr. Yadav on 19th, 20th and 21st of June 2014 on the number used by Mr. Yadav, i.e., 8026639887 by mobile number 09997240909. An audio c.d. of all these conversations is being

sent with this letter. In these conversations Mr. Yadav had admitted out & out the oral fucking chat with my wife. Besides this Mr. Yadav has in two of these conversations admitted his immovable properties at New Delhi and at Ghaziabad (U.P.) purchased in his wife Chitra Yadav's name but he has said that "एक सहायक अधिकारी के तौर पर मैं किसी भी परिवार के सदस्य के नाम पर कोई भी संपत्ति खरीदने की अनुमति नहीं देता" Being a Govt. servant any purchase of immovable property in the name of any family member requires prior permission of the department concerned.

It is clear from these talks that Mr. Yadav has not even intimated his department regarding these properties. Besides this Mr. Yadav has made a lot of other immovable properties, numerous diamond jewellery and gold from the "bribe" taken during the course of his service in P.R.P.D.

If lockers are sealed and raid is conducted the properties of Mr. Yadav may be found to be of 100 crores, made through bribery.

This is a clear cut example of 'assets' disproportionate to the income of a public servant.

Mr. Yadav's morals can be visualized from the fact that he is ready to get her wife Chitra Yadav fucked by any one, who so ever he may

be. Mr. Yadav has accepted it in these conversations, what I ~~was~~ am writing. My yadav is continuously seeking my pardon for his activities.

Now the proof of an offence under section 497 and 292 of Indian Penal Code and an offence under Prevention of Corruption Act are complete from the admissions of Mr. Yadav in the audio C.D. attached with this letter.

- I therefore humbly pray for
- (1) The protection of my identity and prevention from victimization within section 11 & 13 of whistle blowers protection Act, 2011
 - (2) Seizure of lockers and other documents of properties of Mr. Yadav to exactly ascertain his income from 'bribery'
 - (3) Serious action not less than the dismissal from service of Mr. Yadav for such immoral act and corruption of highest degree, besides the launching of criminal proceedings under section 292 & 497 of Indian Penal Code and under Prevention of Corruption Act.
 - (4) In case of my unnatural death, complete liability of Mr. Yadav under section 302 of Indian Penal

code.


