
4. The appeal is accordingly disposed of.



# Brief facts of the Case & Ground for the Appeal

- That the appellant had submitted an application dated 24-07-13 (Copy enclosed as Annexure-1) through the hand on 25-07-2013 with the PIO, North East District Delhi Police under the Section 6 of the RTI Act, 2005 requesting for providing the information as specified in Annexure-1.
- 2. That the PIO, North East District Delhi Police vide their order dated 26-09-2013 was transferred my RTI Application to the PHQ regarding query no. 4(b) (Copy enclosed as Annexure-2) and latter the APIO, PHQ vide their order dated 04-10-2013 further transferred the same RTI Application dated 24-07-2013 to the concerned CPIO, Ministry of Home Affairs, North Block (Copy enclosed as Annexure-3). After this the CPIO, Ministry of Home Affairs, North Block vide their order No. 14039/73/2013-UTS.1, dated 04-11-2013 (Copy enclosed as Annexure 4) had provided the wrong information in respect of query no. 4(b) as sought by me vide my RTI Application dated 24-07-2013. The CPIO had stated in their order dated 04-11-2013 that "no such complaint has been received in UTS-1 desk of MHA".
- 3. That the appellant had seen in the Newspaper Hindustan dated 27-06-2013 (Hindi) (Copy enclosed as Annexure 5) about the malfunctioning of the Addl. DCP, North East Delhi Police on which our Metropolitan Magistrate, Karkardooma Court had sent their letter along with directions to the Ministry of Home Affairs, North Block for taking the action against the Addl. DCP, North East. So the appellant had filed the RTI Application for the purpose of knowing the action that "Whether the Ministry of Home Affairs has taken the action against the Addl. DCP and other Officer of the Police Department of the North East District Police on the complaint of the Metropolitan Magistrate honestly or not?". Thus disclosure of the information is required.

#### Prayer:

 That the disciplinary action u/s 20(2) of the RTI Act, 2005 be taken against the CPIO for not providing the information in respect of query no. 4(b) of the RTI Application dated 24-07-2013.

5. That the PIO be directed to provide the information as sought by me vide query no. 4(b) of the RTI Application dated 24-07-2013.
