Sir / Madam

I am directed to refer to your RTI application on the subject received in this Ministry on 30-10-2013 and received from Director (NE) of MHA on 14-11-2013 and to send herewith point wise information of your application in r/o North-East, as below:-

- (a) If, in relation to any state or Union territory to which this Act extends, the Governor of that state or the Administrator of the Union territory or the Central Government, in either case if of the opinion that the whole or any part of such state or Union territory, as the case may be, is in such a disturbed or dangerous conditions that the use of armed forces in aid of the Civil Power is necessary, the Governor of that state or the Administrator of that Union Territory or the Central Government, as the case may be, may, by notification in the official Gazette, declare the whole or such part of such state or Union territory to be a disturbed area:
- (b) Violence became the order of the day in the North-East due to ethnic clashes and other historical factors giving rise to formation of militant groups (possessing sophisticated weapons) which with cross-border support, challenged the sovereignty and integrity of India. Law and order Machinery in the North-Eastern States became inadequate to counter these militant forces thus calling for deployment of armed forces to aid the civil powers. Hence AF5PA. As regards its non-applicability to Naxal affected areas, the information may be obtained from D5 (NM), Ministry of Home Affairs.
- (c) The present violence level (by militant Groups) warrants deployment of armed forces in aid of civil power in the North East. On security related issues, all factors including the ground reality are taken into account before declaring an area in the North-East as disturbed area under the Act. For instance, in Mizoram &Sikkim AFSPA is not applied and in Tripura and Manipur only partially applied.




