- 2. It is to inform you that the State Governments are primarily responsible for undertaiding necessary rescue & relief measures in the wake of natural disasters including Cyclone. Distribution of relief on ground is also responsibility of the State Government concerned. The Government of India supplements the efforts of the State Governments by providing financial and logistics support, if required, to meet the situation effectively. For this purpose, a State Disaster Response Fund (SDRF) has been constituted with an allocated amount for each State. The State Governments are expected to take relief measures of immediate nature, out of the funds available in the SDRF as per GOI's approved items and norms. These items & norms are uploaded on the website of this Ministry www.ndmindla.in. However, in the wake of natural calamity of a severe nature, assistance is provided from National Disaster Response Fund (NDRF) as per established processor. Additional expenditure, if any, incurred over and above or on other than approved items/norms, or required to be met by the States from their own resources and not from SDRF/NDRF, since these schemes are to supplements the immediate relief efforts of the affected State.
- 3. With regard to point No.(i) in order to support the affected people of Odisha and Andham Pradesh from the Cyclone (Phailin), the Government of India have released an amount of Rs. 1000 crore (Rs.250 crore from SDRF + Rs. 750 crore on account basis, from NDRF) to the State Government of Odisha and Rs. 1000 crore (Rs. 300 crore from SDRF + Rs. 700 crore on account basis, from NDRF) to the State Government of Andhra Pradesh.
- 4. So far as point No.(ii) & (iii) is concern, a copy of your RTI is being transferred to the Ministra of Agriculture in terms of provisions contained in sub-section (3) of Section 6 of the RTI Act for providing information available with them to you directly. You are requested to contact the CPiC concerned for further information in this regard.
- 5. If you are not satisfied with this reply, you pay prefer an appeal under Section 19 (1) of the RTI Act, 2005 within thirty days from its receipt to
