Sir

I am directed to refer to your RTI application on the subject received in the Ministry on 6-11-2013 and received from Under Secretary (RTI) on 18-11-2013 and to send herewith point wise information of your application, as below:-

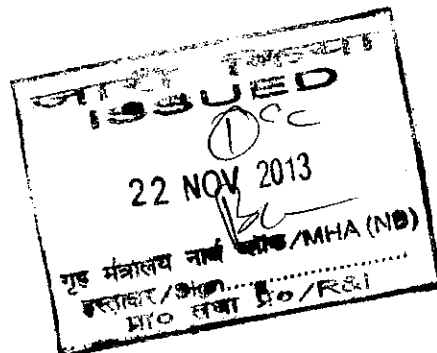
(1) If, in relation to any state or Union territory to which this Act extends, the Governor of that state or the Administrator of the Union territory or the Central Government, in either case if of the opinion that the whole or any part of such state or Union territory, as the case may be, is in such a disturbed or dangerous conditions that the use of armed forces in aid of the Civil Power is necessary, the Governor of that state or the Administrator of that Union Territory or the Central Government, as the case may be, may, by notification in the official Gazette, declare the whole or such part of such state or Union territory to be a disturbed area under AFSPA.

(2) Violence became the order of the day in the North-East due to ethnic clashes and other historical factors giving rise to formation of militant groups (possessing sophisticated weapons), which with cross-border support, challenged the Sovereignty and integrity of India. Law and order Machinery in the North-Eastern States became inadequate to counter these militant forces thus calling for deployment of armed forces to aid the civil powers. Hence AFSPA.

(3) AFSPA is applicable only in areas declared 'disturbed areas' as stated in reply to (1) above. Such notifications are issued periodically after reviewing the security situation. For instance in Manipur, Arunachal Pradesh & Tripura, it is partially applied and in Sikkim and Mizoram it is not applied.

(2) The Appellate Authority in this case is Shri. Shambhu Singh, Joint Secretary (NE), North Block, New Delhi.
