

Sir,

This has reference to Joint Secretary & First Appellate Authority (JS&FAA) (Shri Satpal Chouhan) vide Order No.A-43020/61/2013-RTI dated 14.03.2014 in respect of your RTI appeal No. MHOME/A/2014/60040. In the said order, it is mentioned that your application dated 29.11.2013 was forwarded by Shri V.K. Rajan, DS & CPIO vide their letter No.A-43020/61/2013-RTI dated 12.12.2013 to various Divisional Heads of this Ministry to furnish the information, if available with them. In this regard, it is informed that this letter has not been received by the undersigned CPIO from the concerned Divisional Head i.e JS(IS-I). However, the same has now been found enclosed with the above said Order dated 14.03.2014 (received on 19.03.2014) through JS (IS-I).

2. In this connection, it is stated that in para 27 of your RTI application dated 29.11.2013, you have not indicated any period for which the details of Law Commission's Report is to be sent. Moreover, there is no such compilation available in the Sections under the undersigned CPIO, about the Reports' of the Law Commission received, if any. However, it is informed that during last 10 years, no report from Law Commission was received by the Sections under the jurisdiction of the undersigned CPIO.

3. Besides the undersigned CPIO, there are other 3 CPIO under the JS (IS-I). Accordingly, the above said appellate order dated 14.03.2014 is also being forwarded to them for providing information on point no. 27 of your application, directly to you.

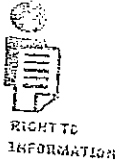
