In this case has been registered against the banned outfit CPI(M). But my query is that why there was not a single case of culpable homicide registered against the officers of security forces. The proof of culpable homicide is as follows:

Information Sought:

a. The security forces were shifted for an unnecessary briefing instead of guarding the convoy of congress leaders.

b. The advance route or road clearing was not conducted by the security forces.

c. The commanding of the area was not done ahead of the return of the convoy.

d. The leaders of the convoy were not informed or not apprehended about the removal of security cover.

All these actions are much more than blatant violation of the basic duties of the security forces.

Why disciplinary action for eausing death of more than 30 innocent people amounting to culpable homicide was not registered against the

offciers of Chhattisgarh State Police and CRPF, even after 6 months of this event.
