2. With reference to above, it is stated that as per Section 2(f) of the RTI Act, 2005, '**Information**' means any material in any form, held by the CPIO.

3. Further, as per Para 10 of the guidelines on the RTI Act, 2005, issued by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training vide O.M No. 1/32/2013-IR, dated 28th November, 2013, '*a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control... The CPIO/PIO is also not required to furnish information which require drawing of inference and/or making of assumptions; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions*'.

4. In view of above, the requisite information sought in your application is not covered under the definition of 'information' the Act.

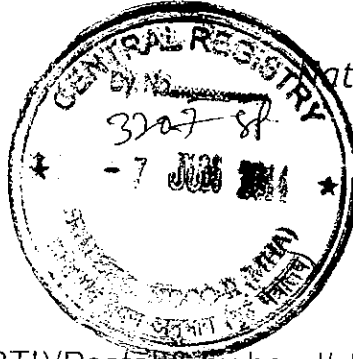

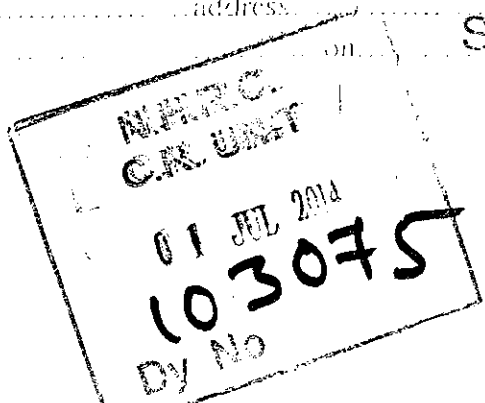
