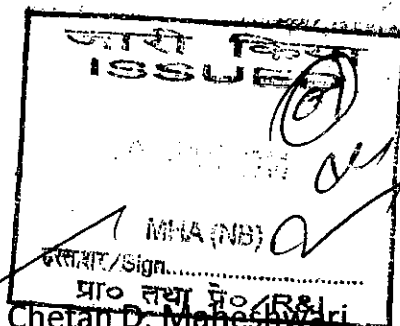

4. The entire State of Manipur excluding Imphal Municipal Area, as notified by the State Government of Manipur.
5. Parts of Tripura (125 Police station in full and 7 in part) as notified by the State Government.
