Enclosed please find herewith a RTI application dated 23.11.2012 (received by answering CPIO on 20.12.2012 through Director(Foreigners) & CPIO, Ministry of Home Affairs vide their OM No.28020/105/2012-F.III dated 20.12.2012) from Dr. Gulshan Kumar Kathuria, No. 168, Yamuna Street, Yamuna Nagar, Haryana (Pin: 135001).

2. The information sought by the applicant in respect of points 1,2 & 4 is not maintained in the FFR Division, as such not available with the signing CPIO. The information in respect of point 3 has been provided to the appellant. The same was conveyed to the appellant on 18/01/2013. The appellant then approached the CIC on 10.04.2013 in a second appeal and CIC has directed Ministry of Home Affairs to provide the information to the appellant on the points mentioned in the RTI application within thirty days of the CIC's order dated 15.01.2014 (which was received by the CPIO on 27.01.2014). A copy of the CIC's order is enclosed herewith.

3. The points on which information required by the Appellant are given below:-

- (i) the number of casualties resulting from the partition of 1947, including the community-wise break-up;
- (ii) the number of displaced persons who crossed over from India to Pakistan and from Pakistan to India;
- (iii) whether any Commission of Enquiry was set up. If so, a detailed report of the Commission set up and its report; and
- (iv) If there is no enquiry report, the reasons for it.
