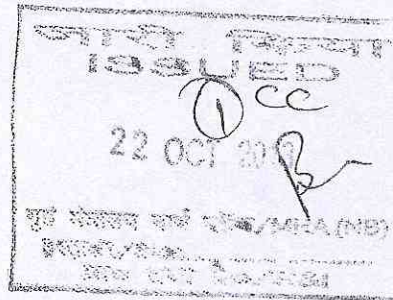
6. The appeal is accordingly disposed of.
