ORDER

Sh. J L Nijhawan has preferred an appeal dated 30.11.2013 stating that he has not received the requisite information called for vide his RTI application dated 25.10.2013 from Police Division, MHA

2. The appellant vide his RTI Application dated 25.10.2013 (received in UTS-I desk on 18.11.2013 through RTI Cell, MHA's OM dated 13.12.2013) sought information related to IPS officers in general which pertains to Police Division, MHA. The CPIO vide this Ministry's letter dated 26.11.2013 furnished the relevant reply within the stipulated time to the applicant thereby intimating that the RTI application is being transferred to CPIO/Director Police, MHA for providing information directly to the applicant.

3. The appeal filed by Sh. J L Nijhawan has been carefully considered and it is found that the aforesaid reply of the CPIO with reference to his RTI application dated 25.10.2013 is in conformity with the Right to Information Act, 2005. However, the CPIO/Director, Police Division, M/o Home Affairs is requested to provide requisite information within the stipulated time directly to the applicant.

4. The appeal is accordingly disposed of.
