With reference to your letter No.14039/15/2013-UTS-II dated 2nd April,2013 on the subject cited above, I wish to submit as under:-

1. that postal order no(s) 709 316959, 056 222 452 & 54 dated 7/5/2013 for Rs. 90/- are enclosed herewith for supplying the copies of documents as mentioned in reply of point no. 1&2 and 9 in your letter under reference. Kindly provide me the copie of documents.

2. that I am a senior citizen and could not attend your office for inspection of documents on 12/4/2013 due to illness. It is however' clarified in response of observation against point 3&4 of my application that the in point- 3, the no of posts were sought as per the reconstituted cadre yearwise from 2003 onwards. Yearwise list of 165 incumbents (promotee DANICS Officers) was sought in this regard requesting for copies record of yearwise bifurcation/yearmarking the posts for Entry Grade/Selection Grade and JAG was sough and this was clearly mentioned in the application. The record may now be provided.

Similary, information sought in point-4 js also very clear. Copies of yearwise eligibility list for promotion and minutes of DPC were sought since the constitution/reconstitution of the cadre, hence specifying the period. The same may now be provided for the years when DPC for promotion were held.

3. As regards point-6, it is once again clarified that the file no. etc. is not available with me. However, the UTS-II Section, MHA is well aware that the quota of departmental promotion was reduced from 66% to 50%. The copies of relevant

Notings giving justification/reason/logic may be provided to me.


4. As regards reply given to point no. 7, it is submitted that the concerned Section UTS-II processes the cases for departmental promotions in DANICS. The details of vacancies and promotee officers is available in DP file and other files of The section. Otherwise, how can they ascertain the no. of posts available for promotion alongwith feedre cadre officers available. Please provide the details.

5. In reply of point no. 8 also it has been mentioned that no such lists are available in the Ministry which is not true. The Ministry obtains lists of feedre cadre officers from all UTs before every DPC. Kindly provide the infotmation/ copies of documents sought.

6. The point no. 10 has been replied in a very casual manner that no such list is readily available in the Ministry. A perusal of pointno 10 in my application would reveal that I had sought information/status of encadrement of ex-cadre posts of DANICS crated from time to time in GNCT of Delhi as requested vide their letter 25/6/1999 from the then Addl. Secy. (Services), GNCT of Delhi. Please provide the infotmation/status now.

I hope that the concerned officials in MHA would be directed to go through my application once again and provide information/documents sought based on my application and above clarification.
