

Diu and Dadra and Nagar Haveli (Civil Service) Rules, 2003, 50% of the Entry Grade posts are required to be filled by promotion from feeder cadre. In DANICS Rule, entry grade and selection grade post have not been mentioned separately, selection grade posts are to be operated Within Part C Schedule-I. Thus, all posts in Part C Schedule-I should be construed as Entry Grade posts till selection grade posts are identified separately. There are 249 Entry Grade and Selection Grade posts and 53 posts are meant for JAG-II and JAG-I. Apart from these posts, 12%, 10% and 10% posts are Deputation, Leave and Training Reserves posts respectively. Accordingly, total 321 posts are earmarked for Entry Grade and Selection Grade. As per Rule 7, 165 posts should be filled by promotion i.e. the representation of Promotee DANICS officers should be 165. Therefore, yearwise list of 165 incumbents (Promotee DANICS) may be provided. In this regard, the copies of record of yearwise bifurcating/ earmarking the posts for

Entry Grade/ Selection Grade and JAG may be allowed to be inspected.

Copies of yearwise eligibility lists for promotion, minutes of DPC for promotion indicating the details of posts of Deputaion, leave and training reserve at each level i.e. Entry Grade/Selection Grade and JAG etc.Year wise quota of Direct Recruit (DR) and Departmental Promotees (DP)under DANICS alongwith the representation of DR:DP in each year.
