2. With regard to seeking information on Para 1 to 8 of the above mentioned RTI application dated 13/12/13, the information is furnished below:

Para 1: Foreigners Division, Ministry of Home Affairs has not conveyed any security clearance for grant of visa to Dr.Tahir Ul Quadri, Canadian national of Pakistani origin to visit India so far *for delivering speeches in various States in India, from Janmy 2014 to February, 2014.*

Para 2,3,4,5: Foreigners Division, Ministry of Home Affairs has not taken any policy decision/ issued such instructions in the matter.

Para 6,7: As per the available information, this Ministry's security clearance for grant of visa to Dr.Tahir Ul Quadri, Canadian national of Pakistani origin to visit India was conveyed on 5/1/2012 on recommendation/reference from Shri Asaduddin Owaisi, MP (Lok Sabha).

Para 8: Foreigners Division, MHA has no information and in this connection you may seek information from the State Govt. of Andhra Pradesh, Hyderabad.

3. If you are not satisfied with the information furnished, you may file an appeal to Shri V.Vumlungmang, Joint Secretary (Foreigners) & Appellate Authority, Ministry of Home Affairs, Foreigners Division, NDCC-II Building, Jai Singh Road, New Delhi within the prescribed time limit.
