Sub: First Appeal filed by Shri Amal Das under the RTI Act, 2005 - regarding.


With reference to the appeal dated 28.07.2014 filed by Shri Amal Das under RTI Act, 2005, the appellant is informed that the undersigned has considered the RTI application dated 07.05.2014, reply dated 22.05.2014 given by the CPIO and the appeal dated 28.07.2014.

2. In his appeal, Shri Amal Das has mentioned inter-alia that he had filed an RTI application on 07.05.2014 asking for copies of both noting and correspondence side pertaining to the file No.1407/01/2009/UTS-I. He has further mentioned that the PIO didn't provide him the requisite reply.

3. However, perusal of the RTI application dated 07.05.2014 reveals that infact the appellant had asked to provide the copies of both noting and correspondence side pertaining to the file in which request of 1991 and 1992 batch DANICS officers for ad-hoc promotion was processed and the copies of the representations submitted by the DANICS Officers' Association. Since, the relevant file was at DoP&T at that time, the CPIO had rightly informed the appellant/applicant about the status. Presently, the said file stands referred to the Department of Expenditure, Ministry of Finance for their advice/comments.

4. The appellant has mentioned in his appeal that he had asked for copies of both noting and correspondence side pertaining to the file No.1407/01/2009/UTS-I. However, perusal of the RTI application reveals that the appellant had not mentioned any file No. in his application. Further, there is no such file having No. 1407/01/2009/UTS-I, as mentioned in the appeal.

5. In view of the above, the appeal has no merit. The reply given by the CPIO is proper and justified and no intervention of the First Appellate Authority is required. However, the appellant is advised to be in touch with the Ministry to get copies of the relevant note and correspondence portion when the relevant file is received back from the Department of Expenditure, Ministry of Finance.

On the basis of above facts I would like to request that:


