    - (ii) Leader of opposition.
  - (e) Representatives from both the Zilla Parishads.
    - (i) Chairperson of the Zilla Parishads.
    - (ii) Leader of opposition of Zilla Parishads
  - (f) Nominated Members representing various interest groups :-
    - Shri Harinarayan Arora, C/O Bharat General Store, Aberdeen Bazaar, Port Blair, Andaman and Nicobar Islands.
    - (ii) Shri Vishal Jolly, C/O Vishall Niwas, Village & Post: Bambooflat, South Andaman, Andaman and Nicobar Islands.
    - (iii) Dr. Rohinder Lall, Rohin's Eye Hospital, All India Radio Road, Ward No. 7, Post: Haddo, Port Blair, Andaman and Nicobar Islands.
    - (iv) Shri Ajay Bairagi, village; R. K. Grampian, post-Diglipur, North Andaman, Andaman and Nicobar Islands.
    - (v) Smt. Durgawati, House No. 150, Mahatama Gandhi Road, Junglighat, Andaman & Nicobar Islands.
    - (g) Joint Secretary (UT) as Member Secretary.
- 3. The Advisory Committee shall be consulted in regard to following matters:—
  - (a) General questions of policy relating to the administration of the territory in the State field.
  - (b) All legislative proposals concerning the territory in regard to matters in the State list.
  - (c) Such matters relating to the annual financial statement of the Union in so far as it concerns the territory and such other financial questions as be referred to it by the President.
  - (d) All developmental issues concerning the Union Territory.
  - (e) Internal security related issues.
  - (f) Any other matter on which it may be considered necessary or desirable by the Minister of Home Affairs that the Advisory Committee should be consulted.

The term of nominated members would be for a period of two years, the Committee shall meet once in a year or as per convenience of the Chair/HM. The office of the member of the Advisory committee shall be honorary and shall not carry any salary or remuneration.
