2. It is also informed that rest of all the points are related to the GNCTD and a copy of the application is transferred to them under Section 6 (3) of the RTI Act, 2005.





2. Details of the permit of the bus no. DLIPC -0149 indicating clearly the period for which the permit of the bus had expired, the period for which the permit had been suspended and complete log of relevant details pertaining to permit.
3. The last notice of suspension issued to the bus DL IPC -0149 vide Challan dt .21/7/2012 was issued by which A.C.P (Traffic) and what was its fate?
4. Out of 8 challans done against the bus no. DLIPC-0149 in how many cases prior to the rape incident did the traffic police intimate to transport department about the bus no. DLIPC -0149 running without permit.
5. In how many cases prior to incident of 16th December 2012, did the traffic police intimate to the transport department about other buses running on road without valid permit? Kindly provide copies of letters sent to transport department

In the imputations of misconduct it has been stated that A.C.P Traffic South East District had sent a request on account of another bus having repeated violations and in which case cancellation of R/C 's had been recommended to the Transport Department , Kindly provide copy and relevant details of the same .
 7. Under what provision of Motor vehicle Act has it been specifically stated that it is the duty of the A.C.P (Traffic) to write to /intimate Transport Department about a Motor Vehicle plying on road without valid permit?
 8. Under which standing order/Notification of Traffic Department has it been specified that while dealing with suspension of cases under 36M.V Act it is the duty of A.C.P Traffic to intimate to the transport department about a motor vehicle operating without valid permit. Please supply certified documents
 9. Copies of the statements of the public witnesses- Shri Sudhir Yadav Special CP traffic, Shri Rajendra Kumar, Commissioner (Transport) GNCTD and Shri S M Ali, Additional Commissioner (Transport) GNCTD, as submitted during the inquiry be provided.
 10. A copy of the detailed report of the Inquiry done by Joint Secretary (Police Modernisation) be supplied.
 11.
