

The Applicant/appellant respectfully submits as, under:

Appellant has filed the RTI, Application dated 01.11.2013 (Copy enclosed as Annexure-A) and subsequently, application was transferred with various quarters and thereafter, received on 12.12.2013 later reply dated 29.12.2013 whereby, application was transferred with Director (IS-II), Ministry of Home Affairs, to provide the information (Copy enclosed as Annexure-B).
