2. Open tenders are invited for disposal of the aforesaid vehicles on terms and conditions mentioned below. Firms/ persons interested to buy the above vehicles are required to submit expression of interest (Eoi) in writing on plain paper to the following address: **Addl. Deputy Director, Subsidiary Intelligence Bureau (MHA), Government of India, Post Box No 75, Tuikual 'A', Aizawl- 796001, Mizoram.** The tenders will be received from 22.11.2021 to 10.12.2021 (1000 to 1700 hours) and auction will be conducted on 13.12. 2021 (1100 hours) at SIB Office, Aizawl in the presence of all the bidders. The auction of vehicles will be on 'as it is' and 'where it is' basis and the vehicles may be inspected on any working day (Monday to Friday) from 22.11.2021 to 10.12.2021 between 1000 to 1700 hours.

3. During the auction process, earnest money (not less than 25% of the bid value) will be collected immediately on the spot from the

successful bidder either in cash or in the form of Deposit-at-Call-Receipt (DACR) drawn in favour of the above addressee. The vehicles will be handed over to the successful bidders only after receiving the balance payment along with documentary proof (Ration Card, Voter I Card, Aadhar in case of individual and Registration Certificate in case of firm, etc.) within three days from the date of auction, failing which earnest money will be forfeited. Ground rent at the rate of Rs. 100/- only will be charged if the respective vehicle is not removed within the stipulated period of three days.

4. The successful bidders will also be responsible for getting the Registration Certificate of the vehicle transferred in their names at their own cost expeditiously. After delivery of the vehicle, the organization will, in no case, be responsible for any lapse, mishap/ accident, etc.
