The award is to be given in the field of Special Operation, Investigation, Intelligence and Forensic Science for excellence in Operations, outstanding service in Investigation, exceptional performance, indomitable & daring intelligence service, meritorious work done by serving Government scientists in the field of Forensic Science.

2. The recommendations shall be submitted through National Award Portal (<https://awards.gov.in>) except in the field of Intelligence. The portal will remain open from 16.06.2026 to 15.07.2026. 3. The recommendations of eligible officials as envisaged in the SOP may be sent/submitted on-line up to **15th July, 2026** except in the field of Intelligence. Recommendation in the field of Intelligence should be submitted in physical mode (sealed envelope) directly to Director (IB), Ministry of Home Affairs, Kartavya Bhavan-3, New Delhi.

4. Copies of the Notification dated 1st February, 2024 alongwith SOP circulated vide this Ministry's letter dated 2nd February, 2024 are enclosed herewith for guidance of the State/UT/Organization level Committee. The following aspect may also be kept in mind while sending recommendation(s):-

- i. No judicial proceedings/departmental enquiry should be pending against the recommendee at the time of considering his/her name for the medal. Moreover, recommendee should not have been given any major penalty or punishment in the last five years.
- ii. Official/officer recommended for one operation, may not be recommended for medal in any other field.
- iii. While submitting online nomination, instructions given in Annexure -"D" may kindly be referred and adhered to.
- iv. Piece meal recommendations may be avoided.

5. The recommendations received after **due date i.e. 15th July, 2026**, will not be considered.
