**Sub: Enhancement of delegation of financial powers to DsG/Directors of CAPFs, AR, NSG, IB, NIA & NPA - reg.**

In supersession of this Ministry's O.M No.II.27012/52/2001-PF-I dated 14.03.2002 and 08.08.2002 regarding delegation of financial powers in respect of following items, approval of competent authority is conveyed on the following enhancement of delegation of financial powers to DsG/Directors of CAPF, AR, NSG, IB, NIA & NPA as per details given below:

(ii)	Reward to guides, Interpreters & informers in operational areas	DG - Rs. 50/- at a time subject to overall limit of Rs. 500/- in a year.	(For CAPFs, AR, NSG, IB & NIA only) DG- Rs. 3,000/- at a time per person subject to overall limit of Rs.30,000/- Per Annum per person.
(iii)	Expenditure on maintenance of Pak & Bangladesh Nationals apprehended	DG - Full Powers to sanction expenditure not exceeding Rs. 15/- per head per day.	(For CAPFs, AR, NSG, IB & NPA only) DG- Full Powers to sanction expenditure not exceeding Rs. 51.43 per head per day (break fast, Lunch & Dinner).
(iv)	Entertainment of distinguished visitors foreign or Indian with whom contacts have to be established for discussions on important matters.	DG- Rs.2,000/- per annum subject to restrictions imposed by Government from time to time.	(For CAPFs, AR, NSG only) DG- Rs.50,000/- per annum subject to restrictions imposed by Government from time to time.

**Note:-** (i) All the above mentioned delegated powers shall be exercised in consultation with the IFA/FA of the Force/Organization.

(ii) This is subject to availability of funds in their budget as well as terms and conditions laid down in DFPR/GFR and guidelines issued from time to time, on the subject by the Ministry of Finance.

3. These delegated powers will be effective from the date of issue of this order.
4. This issues with concurrence of Integrated Finance Division of this Ministry vide E-CF No. 3605908 dated 07.12.2023 and DoE, MoF vide their ID No. 01(08)/2024-E.II(A) dated 17.05.2024.
