- (iv) All the Divisional Heads are requested to direct the concerned Section Officer to speak to SO, R&I, North Block over phone at 12 noon and finalize the time for comparison work on Monday, the 11th February 2019 . The comparers of R&I Unit will compare the fair / final typed copy with the concerned Section Officer/Dealing Hand. In case some corrections are to be carried out in the final reply, the needful will be done by the concerned Section Officer/Dealing Hand then and there. After carrying out, the concerned Section Officer/Dealing Hand will hand over one hard copy of the final reply (after appending his signatures on the reverse of each page) and the soft copy of the Final Reply to the R&I. The Section Officer/Dealing Hand of the Division concerned will be responsible for the correctness of the final reply.****
