I was inducted in the DANICS cadre formed in the year 1996. I was confirmed against the post of Assistant Secretary, and my pay was fixed in the Administrative Selection Grade Rs.8000-275-13500. I retired on 30-4-2001 from Daman Diu Secretariat.

Of late it has come to my notice that the DANICS Rules 1996 were repealed and new set of Rules viz. The NCT of Delhi, Andman Nicobar Islands, Lakshadweep, Daman and Diu, & Dadra and Nagar Haveli, (Civil Service) Rules 2003 were brought into force with retrospective effect from 01-01-1996 by the Ministry of Home Affairs, New Delhi Vide Order No.14012/8/2000-UTS II dated 06-08-2003.

Under these revised rules, Selection Grade 8000-13500 is equated with Rs.10,000-325-15200.

- I therefore, would like to know whether the Ministry of Affairs, has issued orders granting revised pay scales to retired UTS cadre office from Daman Diu-DNH. If so a copy of the said order may please be sent to me at an early date.
- I also request you to kindly supply me a copy of the Civil list od DANICS Cadre
