
Point No. 04:- The applicant is advised to refer to the reply of point no. 01 & 02, *ibid*, which covers reply to point no. 04 also.



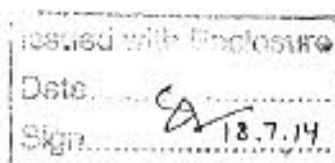
