
Subject: Information sought under Right to Information Act – 2005.

2. The Special Investigation Team constituted by the State Government has filed charge sheet in Hon'ble court against the B.K.Lala, Linga Ram Kodopi, D.V.C.S. Verma, General Manager of Essar and Soni Sodhi on 04.03.2013.
