Sir,

Please refer to your RTI application dated 14/10/2013 addressed to President's Secretariat vide which you had asked about action taken on your request dated 11/10/2013 regarding "making the list 'Undesirable Contact Persons' public". Your petition dated 11/10/2013 addressed to President's Secretariat was earlier received by this Ministry through PMO vide PMO ID No. 1/3/2013-PMP2/98488 dated 31/10/2013. Your RTI application dated 14/10/2013 was also received by this Ministry on 29/11/2013 through PMO vide their O.M. No. RTI/5766/2013-PMR dated 27/11/2013.

2. Your RTI Application was further transferred to DoPT by this Ministry under section 6(3) of the RTI Act, 2005 on 26/12/2013 on receiving the confirmation from the Central Registry of this Ministry that the said PMO letter dated 31/10/2013 was sent to DoPT on 14/11/2013 by the CR Cell.
3. DoPT vide their O.M. dated 06/01/2014 had returned the RTI application to this Ministry informing that they had not received any such petition from Ministry of Home Affairs.
4. Your RTI application was again transferred to DoPT by this Ministry on 28/04/2014 along with a copy of relevant page of the diary register of the Central Registry. However, the concerned Peon Book could not be located despite best efforts.
5. DoPT again returned the RTI application to this Ministry on 23/05/2014 reiterating that they had not received any such petition from Ministry of Home Affairs.
6. In view of the above, no information can be provided by this Ministry in the matter. However, as the matter pertains to DoPT, you may, therefore, obtain information directly from them.
7. The Appellate Authority in this case is Shri Satpal Chouhan, Joint Secretary(Admn.), North Block, New Delhi.

government maintains a list of 'Undesirable Contact Persons' which is till now a secret document circulated only amongst certain public-authorities. But this list should be made a public-document available freely at websites of public-authorities as a warning to members of public to be aware against fraud and undesirable practices by such undesirable persons. This becomes necessary also when certain undesired elements are found to be impersonating dignitaries seated on high posts thus cheating also members of public.

It seems that some amongst decision-takers might be afraid of getting their names leaked for being blackmailed by such 'Undesirable Contact Persons' because of their close links with each other. Making list of 'Undesirable Contact Persons' public, will create much desired fear-psychology amongst such decision-takers who misuse their positions for corrupt means against national and public interest. Instead of wasting public-funds on photo-publicity of political rulers, hard-earned tax-payers' money should be better utilised for revealing list of 'Undesirable Contact Persons' at regular intervals prominently through newspaper-advertisements.
