OFFICE MEMORANDUM

Subject: - Final Estimates for the Financial Year 2022-23 under Grant No. 49-Ministry of Home Affairs, Grant No. 50- Cabinet and Grant No. 51- Police reg.

The undersigned is directed to say that the budgetary outlays at Final Revised Estimates (RE) 2022-23 stage have been communicated to all the stake holders and necessary allocations have been provided/are being provided through re-appropriation/Supplementary Grants, wherever proposals from the Divisions/Organization have been received.

- 2. In order to assess the exact requirement of funds under various heads of accounts, all the budget controlling authorities are required to work out their headwise requirement of funds for the remaining period of the current financial year on the basis of the expenditure incurred up to January, 2023 and funds required vis-avis the RE outlays in each case keeping in view the extant instructions of Ministry of Finance on cash management with particular reference to the expenditure caps during the last quarter and the month of March, 2023.
- 3. The details of actual expenditure of funds within the approved RE 2022-23 allocations under each head of account may be furnished in the enclosed proforma so as to reach the undersigned latest by **05th February, 2023.** Brief, to the point reasons for variation from RE 2022-23 outlay should be furnished in each case. As per instructions of CGA/Audit, vague statements like: 'as per trend of expenditure', 'reduced at RE stage', 'as per actual requirement', 'due to less proposals/claims' etc. should not be used while furnishing the reasons. Ordinarily, demands for funds over and above RE 2022-23 may be avoided unless strong valid reasons exist justifying demand for additional funds.
- 4. In case the details are not received by 05th February, 2023, Final Estimates would be decided on the basis of expenditure reported by O/o CGA and the instructions of Ministry of Finance on cash management.
- 5. The details sought should be sent only in format as prescribed in "Annexure".
