Ref: Establishment of High Court of Andhra Pradesh in Andhra State, in the wake of the Bifurcation.

It is submitted that in the wake of the Bifurcation of State of Andhra Pradesh into State of Telangana and State of Andhra, there has been a demand from Telangana State Chief Minister and Assembly that Common High Court shall not be continued at Hyderabad. The people of Andhra and Elected Representatives of Andhra Pradesh also demanding for the establishment of High Court in Andhra area only and resenting for the common High Court at Hyderabad. Article 214 of Constitution of India and Sec.31 of A.P. Reorganization Act also contemplate separate High Court for each State.

It is submitted that A.P. United Lawyers Front also submitted Representations for the Establishment of High Court in Andhra. The AP United Lawyers Front is contemplating to file Writ Petition in this regard, as the Constitutional rights of people of Andhra are denied and the people of Andhra are facing grave inconvenience to go to Hyderabad, which is located in State of Telangana to pursue their legal remedies. In this regard the following information is required under Sec.6 of Right to Information Act. For which Court Fee Stamps and IPO are appended hereto.

- (a) Kindly furnish information regarding the decision for the establishment of High Court in the newly formed Residuary State of Andhra Pradesh.
- (b) Kindly furnish information when High Court will be established in the residuary State of Andhra Pradesh.
- (c) Kindly furnish information how much time Common High Court at Hyderabad will be maintained.
- (d) Kindly furnish information regarding the proposals received from State of Telangana for the immediate discontinuation of Common High Court at Hyderabad.

- (e) Kindly furnish information regarding the proposals received from State of Andhra Pradesh for the formation of High Court in Andhra Area.
