Paras 4, 5 & 7 : DOP&T had provided dossiers in respect of 12 candidates for DANICS and 3 candidates for DANIPS who were allocated services on the basis of Civil Services Examination, 2011. Out of these 12 candidates of DANICS, the offer of appointment letters were issued on 20.11.2012 to 8 candidates and on 19.02.2013 to 4 candidates. And out of the 3 DANIPS candidates, offer of appointment was issued on 20.11.2012 to 2 candidates and on 19.02.2013 to 1(one) candidate.

Para 6 : All the 12 DANICS probationers are undergoing foundation training in the training institute wef 01.03.2013 and they will join the service after the completion of foundation training. The DANIPS probationer's training will commence w.e.f. 01.07.2013.
