- 2. As regards the information sought in point no. 2 of your application [Total budget allocated to fight Naxalism in the last ten years, year-wise, state-wise), it is to state that the ANO Wing of the Naxal Management Division of MHA has been implementing a scheme namely, 'Construction/Strengthening of Fortified Police Stations' is under implementation in Left Wing Extremist (LWE) affected States, under which 400 Police Stations/Outposts have been sanctioned in the 9 LWE affected States. For this scheme, the Central Government has been providing funds @ 2.00 crore per police station on 80:20 (Centre share: State share) basis. This scheme was approved in June 2010. Under the scheme, a total amount of Rs. 489.65 crore has been released by the MHA to 09 naxal affected States from the financial year 2010-11 to 2013-14. State-wise and year-wise details of funds released from the financial year 2010-11 to 2013-14 are annexed.
