Point No. 4: No other document is available in this context.

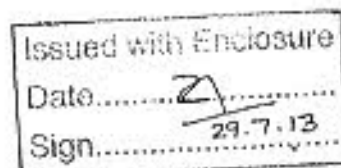
Point No. 5 : Since the entire information is being furnished now, there is no need for inspection of the file.
