Please reply either 'Yes' or 'No'.
- If 'Yes', then intimate what action was taken by the MHA. The entire notings submitted in this regard till the final decision taken on such representation may be supplied to the applicant.
- 5. Whether it is fact that a representation dated 6.12.12 submitted by the under-signed wherein the applicant submitted the copy of O.M. No.22034/4/2012-Estt.(D), Govt. of India, Ministry of Personnel, Public Grievances and Pensions (Deptt. of Personnel & Training) dated 2<sup>nd</sup> Nov. 2012 and the para 12 of the said O.M. clear directed the MHA that

Vigilance Clearance cannot be denied on the grounds of pending disciplinary/criminal/court case against a govt. servant, if the three conditions mentioned in para 2 of this department's O.M. dated 14.9.92 are not satisfied. - 9. Whether it is fact that on 21.3.13 & 18.4.13 DPCs were held for promoting IPS officers of AGMU Cadre of 1987 and 1988 batch. Whether it is fact that the applicant has submitted representation dated 17.4.13 i.e. before the proceedings held by DPC, with the request to consider the promotion case of the applicant keeping the judgement dated 11.4.13 passed by the Hon'ble Justice A.K. Sikri (the then Chief Justice of Punjab & Haryana High Court and now Judge of Hon'ble Supreme Court of India), wherein the Hon'ble Court has clearly given decision that it is only on conviction in a criminal case the convicted employee is debarred from promotion.
- 10.If 'Yes' then intimate what action was taken by the MHA and whether the judgement dated 11.4.13 was put up before the members of the DPC or on the notings of the MHA in the file of promotion.
- 11. Whether it is fact that the promotion case of the applicant was not put up for consideration before the DPC held on 21.3.13 and 18.4.13.
- 12.If so, what were the reasons for not putting his promotion case before the DPC? Please provide the entire notings of the MHA, which was put up before the DPC and decision taken, if any.
- 13. Whether it is fact that on the representations of the applicant dated 14.12.11, 12.9.12, 6.12.12, 9.1.13 and 17.4.13 no action was taken by the

- MHA. If it is incorrect then please provide the action taken & reports, alongwith their entire notings etc.
- 14. Whether it is a fact that the applicant was denied his promotion on illegal grounds and without any rule/instructions. If not, then please provide the copy of the rule/instructions on which the applicant's promotion was denied and his sealed cover was not opened at the time of DPC's held in Nov. 2010 and onwards. Please provide the entire notings of the MHA in this regard.
