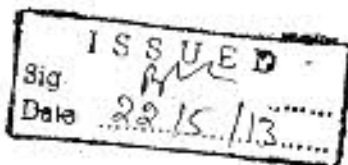

2, 3 & 4.	The names of Sh. Mukesh Kumar Meena was recommended by the Screening Committee duly approved by the Commissioner of Police, for the award of Police medal for Meritorious Service. The copy of the Note-Sheet could not be provided being the Policy matter.
5.	Does not pertain to this office, as the record of punishment in respect of IPS officers are being kept by the GNCTD/MHA.
