Sub.: Information under RTI Act-reg.

Please provide the following information under RTI Act:-

- (i) Please provide the details of mechanism adopted for calculation of vacancy of Grade-II DASS for a particular vacancy year & what is the mechanism adopted to fill up the vacancy meant for direct quota for that vacancy/recruitment year?
- (ii) On the basis of (i) above, please provide the number of vacancy of Grade-II DASS arose in the vacancy year 1994, 1995, 1996 & 1997. While providing this detail, please elaborate the details of carried forward vacancy of direct candidate, if any, with the reason of such carry forward.
- (iii) How the vacancy of direct candidates for the vacancy year 1994, 1995, 1996 & 1997 were filled i.e. please provide the details of the examination through which these vacancies were intended to be filled along-with copies of letter sent to the recruiting agency viz. SSC/DSSB showing the vacancy to be filled.
- (iv) Is the department aware of the Supreme Court judgment in the C.A. No.7514-7515/2005 Union of India & Ors. v. N.R. Parmar & Ors. Related to fixation of seniority direct candidate vis-à-vis promotee?
- (v) Is the department tasking any step to implement the said judgment?
- (vi) As per constitution of India, Delhi is still a Union Territory. In view of this, what is the status of the Grade-II DASS? Is he/she an employee of Union Territory Administration or a State Government or Central Govt.?
- (vii) As per constitution of India, Delhi is still a Union Territory. In view of this, what is the status of an employee of Govt. of NCT of Delhi? Whether he is an employee of Central Govt. or Union Territory Administration or a State Government? Please provide this information in r/o both DANICS (Delhi Andman Civil Service) and DASS (Delhi Administration Subordinate Service) cadre of GNCT of Delhi along with relevant provisions clarifying their status?
- (viii) Is DANICS (Delhi Andman Civil Service) officer a Central Govt. employee?
- (ix) Is the employees of DASS (Delhi Administration Subordinate Service) cadre of Govt. of NCT of Delhi are Central Govt. employee?
- (x) Under which provision the matter related to service conditions / Pay of Grade-II DASS are referred to Ministry of Home Affairs/ DOPT.
