1. Please refer letter F.NO. 14020/01/2014-UTS-I Bharat Sarkar / Government of India ,Ministry Of Home Affairs, North Block dated 18.02.2014 in which four IAS officers of AGMU Cadre have been transferred . Copy enclosed.
2. Out of these four officers ,three officers under Sr. No. (ii) to (iv) have already been relieved by the Secretary Services vide his order No. 148 dated 24.02.2014. Copy enclosed.
3. Sh. Arun Baroka (AGMU 1990) has not been relieved till date whereas the officer shall stand relieved from their charge within 15 days from the date of order.
4. Has any RETENTION been granted to Sh. Baroka because it is a clear fact that he is a CONGRESS AGENT and is working for the benefit of this party for the coming LOK SABHA election? Copy of note sheet along with the recommendation of higher officer/ leader may be supplied.
5. It has also been learnt that he has been staying in Delhi for the last 14 years . Reason for such a long STAY alongwith the rule may also be supplied.

It is submitted that this officer is having several charges of various departments and definately can influence the voters as he had worked with the Congress leaders/ Ministers since long.

Therefore he may be relieved immediately for conducting fair elections in Delhi and copy of relieving order may also be supplied.



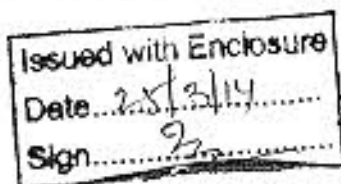


