

**NOTIFICATION**

In compliance of the order dated 13.12.2013 passed by Hon'ble CAT (PB) in OA No. 1692/2011 – Shri Mohinder Singh v/s Government of NCT of Delhi & Anr. read with Hon'ble High Court's judgement dated 14.03.2016 in WP (C) No. 5196/2015 – UOI v/s Shri Mohinder Singh and partial modification of notification No. 14016/6/2003-UTS-II dated 07.10.2004, the Competent Authority in the Ministry of Home Affairs hereby appoints Shri Mohinder Singh [D.O.B.: 09.07.1950] in the Entry Grade of NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli Civil Services (DANICS) in the pre-revised scale of Rs. 6,500-200-10,500/-, against the vacancy year 2001, with effect from the date on which original notification was issued, i.e. 07.10.2004. He is placed at Sl. No. 40-A in the said notification. Shri Mohinder Singh will, get all consequential benefits at par with his junior (Shri Hari K. Meena at Sl. No. 41) in the said notification dated 07.10.2004, vide which 91 officers have been inducted into DANICS for the vacancies years of 2001, 2002, 2003 & 2004. This promotion is in conformity with the provisions contained in Para 6.4.4 of DoP&T's OM No. 22011/5/86-Estt. (D) dated 10.04.1989 that the promotions will have only prospective effect even in cases where the vacancies relate to earlier years.

2. This notification is issued in supersession of notification No. 14016/6/2003-UTS-II dated 08.08.2016.

3. This notification is issued without prejudice, reserving right of the Government to file Special leave petition in the Hon'ble Supreme Court in the matter.
