Subject: Declaration of the Meitei Extremist Organizations of Manipur as Unlawful Associations under sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act, 1967- service of show cause-regarding.

Sir,

I am directed to refer to letter No. 02/Meitei/DHC/2019, dated 30.01.2019 (copy enclosed) received from Registrar, Unlawful Activities (Prevention) Tribunal forwarding therewith an order of the Meitei Extremist Organizations Tribunal dated 30.01.2019 along with true copies of the show cause notices to be served on the above mentioned unlawful associations.

2. The Hon'ble Tribunal in its preliminary hearing held on 30.1.2019 passed an order in respect of show cause notices to be served to the Meitei Extremist Organisations of Manipur along with all its factions, wings and front organizations under sub section 2 of section 4 of the Unlawful Activities (Prevention) Act, 1967 to show cause within 30 days from the date of service of the notices as to why the said Associations should not be declared unlawful and why order should not be made confirming the declaration made under Section 1(3) of the Act. Copies of the show cause notices to be served to these organizations duly signed by Registrar, Unlawful Activities (Prevention) Tribunal is enclosed for ready reference. A copy of order dated 30.01.2019 of the Hon'ble Tribunal in the matter is enclosed.

3. The State Government is requested to take necessary action as directed by the Hon'ble Tribunal.

4. The Service Report is to be submitted to the Hon'ble Tribunal by 25.2.2019. Hence an action taken report on order of the Hon'ble Tribunal may be sent to MHA well before the next date of hearing. Issues of the Newspapers carrying the notices may also be sent to this Ministry for filing affidavit in serving of notice under section 5 of the Unlawful Activities (Prevention) Act, 1967. Also details of broadcasting/telecast in the electronic media, news papers cutting in original and other steps taken in compliance of Hon'ble Tribunal's order, dated 30.01.2019, may be forwarded to this Ministry. The State Government of Manipur may also file a separate Affidavit regarding service of notices to these Unlawful Associations. As per the direction of the Hon'ble Tribunal, Registrar shall check and ensure the compliance of the service of the notice and may take the assistance of two officials of the Tribunal for this purpose and shall file an independent report in this regard before the next date of hearing.


5. Meanwhile as per the order of the Hon'ble Tribunal State Govt. of Manipur is requested to submit their affidavit and documents in support of the grounds on which the aforesaid association has been declared unlawful to the Tribunal and protect the interest of the State Govt. during the course of the hearing in the Tribunal through their Counsel. The next date of hearing in the matter is 05.03.2019 at 4.00 p.m., Delhi High Court, Sher Shah Road, New Delhi- 110 003.

6. Reference is also invited to this Ministry's letter of even No. dated 15.11.2018, action taken thereof by the State Govt. of Manipur may also be forwarded to this Ministry in accordance with Unlawful Activities (Prevention) Act, 1967.

RE: Notification No.S.O. 5681(E) dated 13th November, 2018 issued by the Central Government under Section 3(1) of the Unlawful Activities (Prevention) Act, declaring the Meitei Extremist Organisations of Manipur as 'Unlawful Associations'.

To

The Meitei Extremist Organisations of Manipur, namely,

- (i) The Peoples' Liberation Army (PLA) and its political wing,
- (ii) The Revolutionary Peoples' Front (RPF),
- (iii) The United National Liberation Front (UNLF) and its armed wing,
- (iv) The Manipur Peoples' Army (MPA),
- (v) The Peoples' Revolutionary Party of Kangleipak (PREPAK) and its armed wing, the "Red Army",
- (vi) The Kangleipak Communist Party (KCP) and its armed wing, also called the "Red Army",
- (vii) The Kanglei Yaol Kanba Lup (KYKL),
- (viii) The Coordination Committee (CorCom) and
- (ix) The Alliance for Socialist Unity Kangleipak (ASUK)

along with all their factions, wings and front organizations.

WHEREAS the Central Government in exercise of the powers conferred by Sub-section (1) of Section 3 of the Unlawful Activities (Prevention) Act, 1967 (hereinafter referred to as the "the Act") has declared the Meitei Extremist Organisations of Manipur, namely, the Peoples' Liberation Army generally known as PLA and its political wing, the Revolutionary Peoples' Front (RPF), the United National Liberation Front (UNLF) and its armed wing, the Manipur Peoples' Army (MPA), the Peoples' Revolutionary Party of Kangleipak (PREPAK) and its armed wing, the "Red Army", the Kangleipak Communist Party (KCP) and its armed wing, also called the "Red Army", the Kanglei Yaol Kanba Lup (KYKL), Coordination Committee (CorCom) and the Alliance for Socialist Unity Kangleipak (ASUK) along with all their factions, wings and front organizations as unlawful association vide Notification No.S.O.5681(E) dated 13th November, 2018 [published in the Gazette of India, Extraordinary Part II Section 3, Sub-section (ii)];

AND WHEREAS by Gazette Notification No. S.O.384(E) dated 24th January, 2019 [published in the Gazette of India, Extraordinary Part II Section 3, Sub-section (ii)], in exercise of powers under Section 5(1) of the Act, the Central Government has constituted the Unlawful Activities (Prevention) Tribunal comprising Hon'ble Mr. Justice G.S. Sistani, Judge, Delhi High Court, for adjudicating whether or not there is sufficient cause for declaring the said Meitei Extremist Organisations of Manipur, namely, the Peoples' Liberation Army generally known as PLA and its political wing, the Revolutionary Peoples' Front (RPF), the United National Liberation Front (UNLF) and its armed wing, the Manipur Peoples' Army (MPA), the Peoples' Revolutionary Party of Kangleipak (PREPAK) and its armed wing, the "Red Army", the Kangleipak Communist Party (KCP) and its armed wing, also called the "Red Army", the Kanglei Yaol Kanba Lup (KYKL), Coordination Committee (CorCom) and the Alliance for Socialist Unity Kangleipak (ASUK) along with all their factions, wings and front organizations as unlawful associations as required by sub-section (1) of Section 4 of the Unlawful Activities (Prevention) Act.

NOW THEREFORE, a notice is hereby given to you under sub-section (2) of Section 4 of the Act and you are hereby called upon to show cause in writing within 30 days from the date of service of this notice as to why your associations should not be declared as unlawful and why order should not be made confirming the declaration made in the above-mentioned Notification.

The objections/reply/written statement, if any, may be filed/delivered within the statutory period of 30 days from the date of service to the undersigned at his office in Room 213, Administrative Block, Delhi High Court, Sher Shah Road, New Delhi. In case objections/reply/written statements and documents are in regional language, their true English Translation be also attached.

You are required to appear before the Tribunal on 5th March, 2019 at 4.00 p.m. at Delhi High Court, Sher Shah Road, New Delhi-110003 for further proceedings. Appearance can also be caused through a duly authorized and instructed Counsel/Advocate.
