## **OFFICE MEMORANDUM**

Subject: Issue of MHA Parking Labels for the year 2024.

The undersigned is directed to say that the validity period of MHA Parking Labels issued by this Ministry for parking vehicles in the premises of Government Buildings under MHA security cover for the year 2023 will expire on 31.12.2023. New Parking Labels for the year 2024 will be issued from 01.12.2023 onwards. The staff of Pass Cell will be available from 10:00 AM to 01:00 PM and 02:00 PM to 04:30 PM to issue the Parking Labels. Vehicles are required to be physically available on the spot as the labels will be affixed on the windscreens of the vehicles by the Pass Cell staff themselves. In no circumstances the label will be handed over to the official/driver of the vehicle.

2. Applications, in the following **prescribed proforma** (whichever is applicable), duly sponsored by the competent authority along with the requisite documents mentioned therein, may be submitted to the Pass Cell at Jalebi Chowk, North Block, New Delhi, starting from 01.12.2023. Please submit them in a single bunch, not exceeding a set of 50 applications.
